Subject: Tree Champions

Good evening everyone

As the Nature Recovery Strategy being led by Leics CC progresses, it is obvious that we need to start preparing ourselves. It is important that the strategy is real to our parishe; something they work within and not have done to them. A first step toward that is for every parish to have a Tree Champion.

A Tree Champion requires no qualifications or experience but just a passion to enhance and retain the treed environment. Together with Stuart Kidd (our Tree Officer) they hold discussions on growing trees from seed, planting schemes, whistle blowing (on unlawful tree work), maintenance work (e.g. watering), issues with trees, or anything else that the group wants to discuss about trees.

Tree Champions vary from parish to parish but are typically selected by a parish council. Some of the Councils have trees amongst their assets, but some have little or no land with trees. Some find it relevant because they are within a conservation area, or work beyond their parish council with other volunteer groups. The meetings are always informal and welcoming.

During the meetings Stuart helps to develop the Tree Champions' knowledge with discussions on risk, tree condition, pests, diseases, planting techniques, and the law. He also answers questions that they may have about RCC's approach to tree management. The only item kept to a minimum, or avoided altogether, is individual planning applications specifics because they can prejudice a case against the Planning Department.

The group also learns from each other, sharing ideas and joining together of schemes. Anyone is welcome who wants to contribute and become a Tree Champion.

The parishes below do not currently have a Tree Champion that attends meetings although Uppingham is in the process of appointing one. I wonder if you could encourage your parish councils and meetings to think about this important role. The council may not have any trees on its land currently but we would like them to be involved in planting schemes going forward. Any questions can be directed to Stuart or me.
